GACA Services Charge Instructions

Background: GACA has introduced a new service charge in returning to its rule to supervise and monitor the activities related to passengers performed at King Abdulaziz International Airport, King Khalid International Airport, and King Fahd International Airport.

Instructions:

- Airlines shall collect SAR (5) GACA Services Charge from each departing passenger on domestic or international flights including transfer passengers at KAIA, KKIA, and KFIA.
- 2. GACA services charge shall be applied for travel periods starting from 01 Nov 2023 and thereafter.
- 3. The charge is collected directly from passengers as part of the ticket fare.
- 4. According to invoicing instructions, Airlines shall pay the collected Charge directly to GACA.
- 5. Airlines can settle GACA services charge on sold tickets according to the GACA circular that will be issued later.
- 6. GACA services charge are not collected from the following passenger categories:
- Arrival passengers.
- Infant passengers.
- Crew members assigned to perform duties on board including (pilots, aircraft engineers, cabin crew members, or technicians).
- Crew members who have been registered on the airline carriers' list as cabin crew members and hold an identification badge (pilots, aircraft engineers, cabin crew members, or technicians).
- Transit Passengers who will stay inside the aircraft and will not use airport facilities.
- Sky marshals returning on the same aircraft.
- General aviation passengers
